Online classes will be conducted via Zoom. Invitation will be sent directly to parent's email.

Details of the Program: Parent Child Resource Centre Zoom account will host the online class. Learning materials will be delivered to you prior to the start of the course. Each session is filled with interactive activities with songs, stories, lessons and discussions, reflection and sharing time.

All online engagement programming will be hosted through Organization's licensed account, regularly monitored by Organization Leadership. Attendance will be taken at the beginning of all online programs. All sessions will be recorded for security purposes and maintained on a confidential drive permanently.

We have taken precautions in providing this programming. However, we feel we have the responsibility to share with you the risks associated with any online activity. These risks include but are not limited to: risk of your child switching screens and viewing age inappropriate content, risk of online predators securing access, your child disclosing personal information and cyberbullying, and viruses or other online gatherings risks.

The undersigned agrees to release Parent Child Resource Centre, its director, employees, and volunteers from any loss, personal injury, accident, misfortune or damage of the participant and/or his/her personal property during the online meetings. Parent Child Resource Centre will exercise reasonable precautions to ensure the health and safety of the participant. In case of injury or loss, the participant has to be covered by his or her own insurance policy, applicable provincial health plan or own expenses. Parent Child Resource Centre is not responsible and liable for any claims or loss from the participant.

Parent agrees to participate as the following:

1. Attendance will be taken at each online gathering by the teacher. A parent must be in the room at the beginning and at the end of the online class. This is our check in and out process.
2. For Grade 1-5, Parent should remain in the same room as their children when they are on the online class. Do not leave your children in front of the computer alone in an isolated room.
3. Parents are requested to ensure that the online class be played on computer/device with speakers instead of earphones/headphones.
4. Webcam will be on since each gathering will be recorded.

Parent Child Resource Centre will record all the online meetings for security purposes. Videos recorded will be kept safe and private. The undersigned grants permission for any video and/or pictures of his/her child and the reasonable use of pictures containing his/her child in any or all of the following ways: brochures/promotional material, church, website, newsletters and videotaping. The participant must agree to follow the Parent Child Resource Centre rules, policies and guidelines. If the participant refuses to follow, he or she can be refused to the online meetings and can be suspended from the program.
